RESORT CHARGE

With Resort Charge you can attach a credit card to your Season Pass and use it to charge at Stowe Mountain Resort's on-mountain restaurants and retail locations. If you choose to take advantage of Resort Charge, you also have the option to sign-up for Direct to Lift access. Direct-To-Lift privileges enable you to bypass the ticket window and go directly to the lift through an automatic charge to your credit card. When your Season Pass scans at the gate, your credit card will be charged a discounted daily lift ticket rate. Use the Direct-To-Lift feature when your Season Pass is restricted. If you choose to enable Direct-To-Lift privileges, please be aware of restricted dates associated with your pass.

Resort Charge Agreement:

I hereby authorize a Vail Resorts affiliate company to charge my credit card each time my Season Pass is presented for charging privileges at participating establishments. I understand that some restriction may apply. I understand that I will be responsible for all charges made using my Season Pass and that I am responsible for securing my pass. Please report lost or stolen passes immediately.

Direct-To-Lift Access Agreement:

SEASON PASS HOLDER REGULATIONS

1. The Season Pass is for your personal use only. It is not transferable to another person.
2. If your Season Pass is lost, stolen, mutilated or otherwise deemed unusable, a replacement pass can be issued at the Season Pass Desk with the purchase of a new Evolution Stowe Card (\$5). The old season pass will be deactivated and WILL NO LONGER WORK at the gates.
3. Use of the Pass by anyone other than the person to whom it is issued, or use of a Pass reported "LOST" may result in the confiscation of Pass and revocation of privileges at Stowe Mountain Resort, and/or prosecution for theft.
4. Pass holder agrees to carry and voluntarily display the Pass if asked by Stowe Mountain Resort staff.
5. I understand that Stowe Mountain Resort is not responsible in any way for anyone who utilizes terrain beyond the open and designated trail system (12 VSA 1038).
6. Failure to abide by these regulations as well as Your Responsibility Code may result in denial of skiing privileges with no refund.
7. This Season Pass may be revoked physically and/or electronically by management, their designees and/or Ski Patrol, without refund at any time for misconduct, misuse, or nuisance.
8. Please be prepared to have your pass scanned prior to lift access. If pass holder is under 18, signature of parent/legal guardian is required before skier/rider will be allowed to pick up and/or use the season pass.

SEASON AGREEMENT - EXPRESS ASSUMPTION OF RISKS and FORUM SELECTION AGREEMENT

I understand and accept that skiing, snowboarding, cross-country skiing and other forms of winter mountain sports in which I may participate at VR US Holdings II, LLC d.b.a. Stowe Mountain Resort ("SMR"), are hazardous, with many inherent risks and resulting injuries or death. I acknowledge that my season pass affords me significant discounted access to winter sports activities at SMR. Therefore, in consideration of this, my knowledge and understanding of these sports and the benefits, terms and conditions of my season pass agreement, and being allowed to use the premises of SMR and participate there in winter sports activities, I freely and willingly accept and voluntarily assume all risk of property damage, personal injury, or death which occurs at SMR and which results from my participation in such winter sports activities and the inherent risks of such activities as they are defined herein.

I further agree that the phrase "inherent risks" means those risks, which are listed in this agreement, or those that can reasonably be inferred therefrom. I further agree that these risks are both obvious and necessary to these winter sports activities. I agree that these inherent risks include but are not limited to changing weather conditions, snow conditions as they may from time to time exist and change or be affected by weather, skier, or other participant usage (whether such conditions are surface or subsurface or consist of ice, hard pack, powder, packed powder, wind pack, corn, crust, slush, cut up snow, and/or machine made or machine enhanced snow); other conditions including bare spots, forest growth and debris, stumps and trees, stream beds, water and/or waterbars and other such conditions, whether or not they are visible, and/or collisions with such objects; collisions with lift towers, signs, posts, fences or other enclosures, training or event equipment or structures, water and/or air pipes or other manmade structures and/or their components such as hydrants used in snowmaking or for other necessary purposes, whether or not these objects are marked, padded or shielded; collisions with well marked or plainly visible snowmobiles, snow grooming or other over-snow vehicles or equipment; collisions with other skiers, riders or others; variations in steepness of terrain including but not limited to roads and/or other terrain modifications, features or variations which occur naturally or as the result of slope design, feature design, weather events and/or changes, snowmaking and/or snow grooming operations, or participant usage.

Therefore, in consideration of all of the above I AGREE THAT I WILL NOT MAKE ANY CLAIM NOR BRING ANY SUIT FOR DAMAGES, INJURY OR DEATH TO MYSELF, WHICH RESULTS FROM ANY SUCH INHERENT RISKS, as I have agreed they are defined herein. I also agree, that in the event that anyone makes any claim against SMR, or any of its respective officers, directors, shareholders, agents, employees and/or volunteers, as a result of any of my activities on their premises or the use of their facilities, that I will, to the fullest extent allowed by law, defend, indemnify and hold harmless SMR from such claims.

I FURTHER RELEASE AND GIVE UP ANY AND ALL CLAIMS AND RIGHTS THAT I MAY NOW HAVE AGAINST SMR AND UNDERSTAND THIS RELEASES ALL CLAIMS, INCLUDING THOSE OF WHICH I AM NOT AWARE, THOSE NOT MENTIONED IN THIS RELEASE AND THOSE RESULTING FROM ANYTHING WHICH HAS HAPPENED UP TO NOW.

I further agree that any dispute arising under this contract and/or from any use by me of any of the premises or facilities at SMR shall be litigated exclusively in the Superior Court of Lamoille County, Vermont, or the U.S. District Court for the District of Vermont.

This contract may also be plead as an affirmative defense to any claim that I might make as a result of any damage, injury, and/or death, which I may sustain as a result of my participation in and caused by the inherent risks of winter sports. I further agree that this contract is binding upon myself, my heirs and assigns.

To the extent that I am signing this document on behalf of any minor, I represent and guarantee that I have full authority to do so realizing the full binding effect of this contract on them as well as on myself. I further agree to indemnify and hold harmless SMR for any claims brought on behalf of the minor relating to any damages allegedly sustained by the minor while he/she was participating herein.

I acknowledge that I have read, agree with, and understand the terms of this Express Assumption of Risks and Forum Selection Agreement and that I am signing it freely and that the terms of this contract state that I expressly assume all risk of damages, injury and/or death resulting in any way from any inherent risks of the sport in which I may participate at SMR. I also agree to abide by the terms of any rules of conduct for sports participants posted at SMR or contained in its seasonal trail maps or brochures.

This document is a legally binding contract, but is not intended to assert any claims or defenses which are prohibited by law. If any portion of this Agreement is deemed unenforceable, the remainder shall be given full force and effect.

I grant SMR permission to use my image in advertising and promotional materials in the event that it is captured on the premises.
